Purchasing a property

- Facilitating the payment of stamp duty and deposit.
- Negotiating an extension to the Cooling-Off period if required.
- Arranging final settlement.

Selling a property

- Preparing the Contract of Sale for your property before it goes on the market.
- Reviewing and explaining the terms and conditions in your Real Estate Agency Agreement if required.
- Negotiating with the purchaser's solicitor on your behalf.
- Making any necessary amendments to the Contract and liaising with the real estate agent.
- Facilitating the exchange of contracts and receiving the deposit.
- Discharge of any existing mortgage on your property.
- Facilitating final settlement.
